Database shadowing uses the live processing of remote journaling, but creates even more redundancy by duplicating the database sets to multiple servers. There are also additional redundancy options available within application and database software platforms. For example, database shadowing may be used where a database management system updates records in multiple locations. This technique updates an entire copy of the database at a remote location. Data clustering refers to the classification of data into groups (clusters). Clustering may also be used, although it should not be confused with redundancy. In clustering, two or more "partners" are joined into the cluster and may all provide service at the same time. For example, in an active-active pair, both systems may provide services at any time. In the case of a failure, the remaining partners may continue to provide service but at a decreased capacity.
