Discussion: Finnegan chose to divide his retirement assets equally among the offered asset classes. This reflects the behavioral trait known as 1/n diversification. Knowing generally that they should diversify their portfolios but unsure of exactly how to go about doing that, plan participants invest equal amount in each fund in the list of funds provided by the plan sponsor. They tend to assume that all the funds provided by the employer/sponsor are appropriate for their individual portfolios. Recognizing the potential for 1/n diversification, the sponsor should provide a list of funds that if held together would provide a well-diversified portfolio.
