They aren't valid in any other context.IAM Database Authentication for MySQL and Amazon AuroraWith Amazon RDS for MySQL or Aurora with MySQL compatibility, you can authenticate to your DB instance or DB cluster using AWS Identity and Access Management (IAM) database authentication. With this authentication method, you don't need to use a password when you connect to a DB instance. Instead, you use an authentication token.An authentication token is a unique string of characters that Amazon RDS generates on request.Authentication tokens are generated using AWS Signature Version 4. Each token has a lifetime of 15 minutes.You don't need to store user credentials in the database, because authentication is managed externally using IAM. You can also still use standard database authentication.IAM database authentication provides the following benefits:\* Network traffic to and from the database is encrypted using Secure Sockets Layer (SSL).\* You can use IAM to centrally manage access to your database resources, instead of managing access individually on each DB instance or DB cluster.\* For applications running on Amazon EC2, you can use EC2 instance profile credentials to access the database instead of a password, for greater security.For more information please refer to the below document link from AWS\*

You can use roles to delegate access to users, applications, or services that don't normally have access to your AWS resources. For example, you might want to grant users in your AWS account access to resources they don't usually have, or grant users in one AWS account access to resources in another account. Or you might want to allow a mobile app to use AWS resources, but not want to embed AWS keys within the app (where they can be difficult to rotate and where users can potentially extract them). Sometimes you want to give AWS access to users who already have identities defined outside of AWS, such as in your corporate directory. Or, you might want to grant access to your account to third parties so that they can perform an audit on your resources.
